Danzfest, in partnership with the City of Cattolica (Rimini, Italy), will take place from July 12th through 24th 2010 at the following civic venues: Teatro della Regina, Arena del Teatro della Regina, Ridotto del Teatro della Regina, Centro Danza Regina, La Nuova Accademia, Palestra Comunale, Piazza Mercato.

Danzfest welcomes both professional and non-professional dance students of all nationalities.

Students may register for classes according to their age and skill level. Changes in class assignment may be made during the first 3 days of classes according to skill level of the student.

The Artistic Directors reserve the right to implement variations to the teaching schedule for logistic and/or practical purposes during the course of the summer school session.

Danzfest requires that each participant has:

- 1) Personal injury insurance. Danzfest is exempt from any civic and/or penal responsibility regarding participation in the summer school;
- 2) Current photo identification confirming the first name and surname of the participant;
- 3) Parental consent for minors.

The use of photographic or video devices is prohibited during lessons unless authorized by Danzfest management. Participants give Danzfest the right to reproduce and/or publish photographic or video images taken during the summer school for promotional, broadcasting, and press purposes. Participants give Danzfest the right to use personal data for administrative and management purposes.

Tuition fees will not be refunded once the summer school session has begun. In the event that fees are refunded prior to the summer school start date, a €50.00 processing fee will be applied.

A Certificate of Completion will be awarded to those participants who attend all classes of the Danzfest summer school program for which they are registered and including three University of Bologna seminars, and all scheduled demonstrations. The certificate fee is included in the tuition costs.

1) *Liability.*

The Danzfest management does not assume any responsibility for the risks, dangers, damages, and hazards associated with dance training that takes place at the summer school venues. By completing Danzfest registration forms, the participant exonerates Danzfest from any responsibility thereof and furthermore assumes full responsibility for any eventual personal damages.

2) *Exoneration from liability for participants' personal possessions.*

Danzfest (also referred to as *the organization*) is exonerated from any liability for loss, theft, or damage to participants' personal property while on the summer school venue premises.

3) Exoneration from supervisory responsibility for the organization and its staff.

The organization and its staff are exonerated from supervising minors outside of scheduled class time. Therefore, during non-scheduled class activity hours, including commuting time between host venues, the organization and its staff will not be liable for the supervision of minors.

4) Exoneration from responsibility as outlined under art. 2048 c.c.

The organization and its staff are exonerated from the responsibilities outlined in art. 2048 c.c. regarding damages caused by the participant while under the supervision of the organization’s staff.

5) Medical Certificate.

The participant must be in possession of a valid medical certificate attesting to his/her suitability to undertake the indicated physical activities of the program. Medical certificates must be issued no more than 12 months prior to the start date of the summer school.

6) The Court of Rimini will have jurisdiction over any disputes or controversies that may arise.
